3 **A RESOLUTION APPROVING ADMINISTRATIVE LETTERS 09-02 AND 09-**
4 **03, INTERPRETING AND CLARIFYING THE COLLECTIVE BARGAINING**
5 **AGREEMENT BETWEEN THE MUNICIPALITY OF ANCHORAGE AND THE**
6 **ANCHORAGE POLICE DEPARTMENT EMPLOYEES ASSOCIATION**
7 **PURSUANT TO ANCHORAGE MUNICIPAL CODE SECTION 3.70.130B.**

9 **WHEREAS**, a collective bargaining agreement between the Municipality of
10 Anchorage (hereinafter "MOA") and the Anchorage Police Department Employees
11 Association (hereinafter "APDEA") was ratified by the Assembly on December 16,
12 2008 (AR 2008-307); and
13

14 **WHEREAS**, since ratification by APDEA membership, and following concerns
15 expressed by the Assembly, the parties have found technical errors in the contract,
16 requiring correction by Administrative Letter pursuant to Anchorage Municipal Code
17 (AMC) section 3.70.130B.; and
18

19 **WHEREAS**, Administrative Letter 09-02 adds an inadvertently omitted 'meet and
20 confer' section, pursuant to Anchorage Municipal Code section 3.70.020B., to
21 Article XXVIII of the contract, inadvertently omitted; and
22

23 **WHEREAS**, Administrative Letter 09-03 inserts an inadvertently omitted provision for
24 Accidental Death & Dismemberment (AD&D) insurance coverage into Article XIX; and
25

26 **WHEREAS**, pursuant to AMC section 3.70.130B., these administrative letters,
27 clarifying the contract, require review and approval by the Assembly; and

29 **WHEREAS**, the Administration recommends the Assembly review and approve these
30 Administrative Letters, clarifying the APDEA collective bargaining agreement; now,
31 therefore,

33 **THE ANCHORAGE ASSEMBLY RESOLVES:**

35 **Section 1.** Pursuant to AMC sections 3.70.020B. and 3.70.130B., Administrative
36 Letter 09-02, attached hereto and incorporated herein by reference, adding a new
37 section to Article XXVIII, requiring the parties to meet and confer in good faith, is
38 hereby approved.

40 **Section 2.** Pursuant to AMC section 3.70.130B., Administrative Letter 09-03,
41 attached hereto and incorporated herein by reference, adding inadvertently omitted
42 Accidental Death & Dismemberment insurance coverage to Article XIX, is here by
43 approved.

1 **Section 3.** This resolution shall become effective immediately upon its passage
2 and approval by the Assembly.
